- 2. Insertion of their final, 17.— After rule 16 of the Goa Registration of Tourist Trade Rules, 1985, the following rule shall be inserted, namely:-
  - "17. Submission of data of tourists residing in the hotels, etc.— (1) Every person running the business of hotelkeeper under rule 3 shall submit Statistics on a monthly basis before 5th of the month succeeding the month to which its pertains containing the details of the tourists residing in his hotel/Other Accommodation unit. Such Statistics shall be submitted in the Electronic mode only as per software

developed by Goa Electronics Limited in Form XI, herewith.

- (2) Those hotels/Other Accommodation units who do not submit Statistics as stated in sub-rule (1) shall be liable to a fine of Rs. 25,000/- (Rupees twenty five thousand only) at the first instance and a fine of Rs. 50,000/- (Rupees fifty thousand only) for every subsequent default.
- (3) While submitting such Statistics following processing fee shall be charged:-
