In order to facilitate voters to cast their votes, a public holiday is declared on 10.05.2023, Wednesday to all the Central and State Government Offices, Schools, Colleges, various Organisations and Private Institutions (including Aided and Un-Aided Educational Institutions) within the respective polling area.

All Government Employees deployed for election duty shall attend the same.

For smooth conduct of polls with respect to the polling stations set up in Government Offices and Schools, a decision may be taken by the respective Returning Officer to declare a Holiday on 09.05.2023 and also in view of counting on 13.05.2023.
